#### 4. Report back

- Joakim is finalizing the preparations for the Board meeting.
- Sibylle reported back on:
  - The Rethinking Arms Control conference organized by the German government the previous week.
  - Working with the Universities of Stockholm and Uppsala on a joint letter of interest about the national knowledge centre for nuclear disarmament in Sweden. The proposal is for Stockholm University to host the new centre. The letter is to be submitted to Swedish Research Council on 13 November.
  - The EU Non-Proliferation Consortium network meeting on 9 November.
- Jannie reported back on the meeting she, Dan and Joakim had with the head of the MFA's department for UN policy, conflict and humanitarian issues Carl Skau on Nov 9. The issues discussed included the Stockholm Forum and the MFA's initiative on Good Peacebuilding Donorship.
- Dan has completed the update of the Institute Strategy. He will share it with the Board members and then with SMT.
- Maria reminded SMT about the 13 November deadline for submitting applications under the strategic MFA grant.
- Joakim referred to the possibility to apply for additional MFA funds outside the strategic grant, administered by NIS. Project ideas (not fully developed concept notes) should be submitted for discussion with NIS colleagues by mid-December. Joakim will double check how the process is expected to work.

- Gregory has accepted another position and has submitted his resignation from SIPRI.

6. SSC 2020 – update

- Luc shared with the SMT latest details relating to preparations for the SSC. Registration for the SSC sessions is going well. All sessions are open except the one on security cooperation in Africa.
