#### Participants

#### 1. Minutes approval

- Minutes of the 17 January meeting were approved with minor changes.

#### 2. Matters arising from the Minutes, not otherwise on the agenda

- A brainstorming meeting with SIPRI staff and associates with nuclear expertise will take place on 9 March.  
- Sibylle plans to attend the Carnegie International Conference on Nuclear Policy 20 - 21 March.

#### 3. Report back

- Stephanie is monitoring the Yearbook timetable and will be in contact with authors and relevant Directors of Studies in case there are concerns regarding deadlines.  
- SIPRI is planning two events at the Munich Security Conference on 17 - 19 February, on the themes of 'The Security Horizon in a Disorderly World', and an 'Arctic Security Roundtable'.  
- The Russia-China seminar organized at SIPRI on 16 - 17 January was a success, both according to own impressions and ample positive feedback.  
- Hugh Griffiths, SIPRI colleague on leave of absence for work at the UN, will deliver a seminar on 22 February on UN sanctions and the DPRK.  
- The Swedish MFA visit to SIPRI on 19 January was very successful.

#### 4. Staffing and Projects

- EU working group CONOP on 23 January approved a no-cost extension for the current EU Non-Proliferation Consortium until 2 July 2017, and all but approved a concept note paving the way for a third three year phase for the Consortium in 2017 - 2020.

#### 7. SIPRI Data Use Policy

- It was decided that a working group, led by Lena, should be tasked to develop a draft SIPRI data use policy, including a price scale.

#### 8. Items carried forward for future agenda

- Finalisation of the evaluation of performance assessment and salary review process (early February).
- Finalisation of job descriptions for all staff (early March).
- Titles for researchers and 'research administrators' at SIPRI (mapping forthcoming).
- Design of a more activities based SIPRI budget.
- SIPRI values discussion.
