Information from the Operations team. (Lena)

Conflict & Peace Cluster update - 2019 Stockholm Security Conference. Luc informed this A&D Cluster meeting on the current planning progress for the 2019 Stockholm Security Conference. It will be a one-day event on 3 October with 150 participants. The Conference will focus on continuing to examine the relationship between conflict and technology. There are plans for an opening plenary and closing plenary and six breakout sessions throughout the day.

Conflict and Peace Cluster update on MENA Programme/Project.
Luc reported on the current status of developing a MENA Programme within SIPRI. Time was invested in thinking through a concept of what a MENA Programme could be at SIPRI with consultant Johan Schaar leading this work. Johan Schaar has written a report and this will be published shortly. What emerged has not really been an internal mapping exercise but such an exercise would be fruitful for making some decisions at this point on developing a MENA Programme in SIPRI. SMT considered the option of hiring a Senior Researcher to initiate and develop a MENA programme but the thinking now is to hire a more junior person. This individual would help with our current work in the MENA region but also map the research work being carried out Institute wide on the MENA region. Management are taking a pragmatic approach and once the Institute mapping is done the MENA Programme can develop further from there. Recruitment may start over the summer and it is already planned for in this year's budget. If we can use MENA as a testing ground for linking the thematic and regional interests within SIPRI it would be a very useful exercise.

Nothing further from AMEX as project work continues and summer staff vacation is planned and being taken over the summer months.

Nuclear disarmament, arms control and non-proliferation

Staff is reminded there is a closed SIPRI in-house meeting with IISS (London) on 18 June, in the Boardroom, with 14 participants in total. The meeting is looking at the case experiences with denuclearization of Iraq and South Africa and how that could be applied to future situations in the Korean Peninsula. Shannon will report back at the next Cluster meeting.

DUAT

EXBS workshop planning continues for both the first workshop on 25/26 June about investigating and prosecuting violations of dual-use and arms export

controls, and the second on 10/11 September about inter-regime dialogue. Other project work continues and summer staff vacation is planned and being taken over the summer months.

Emerging military and security technologies.

Concept notes/Grant Applications Excel - any updates?

The A&D Excel sheet containing known concept notes about project proposals in circulation and actual applications under process and in GAD as of June 2019 was circulated to the Cluster. Cluster staff is once again asked to make sure they take some time to check the document once it is circulated again.

New calls!

The DoS has sent information to the PDs' about the latest Norwegian call <<https://grants.mfa.no/#call/1461>>. If anybody has interest, please note an application will need to be submitted by 27 June. This needs to be coordinated with Lena and Vitaly has expressed an interest, so please coordinate accordingly. *Note – Lena is on vacation from 14 June and back in the office on 24 June. There is no decision yet on SIPRI's previous Norwegian application.

SMT – Sibylle

SMT had a discussion about what to send into the MFA for the next UD grant. The ambition is to have a 3-year grant application but this is not certain at the moment. By mid-September, the application will be with UD and close coordination is needed over the summer with the PDs' to prepare properly. There are two processes happening now in parallel. The first is about the big strategic priorities being given to UD, dealing very broadly on issues about increasing transparency and accountability that SIPRI work on. The second process requires that we do more detailed work internally and work with Lena on the budget planning. We need to know and make sure that whatever we promise can be delivered.

A Cluster strategy will be finalised over the summer. The Governing Board requested detailed Cluster strategies as an annex with basically a two-page document from each of the Clusters with a five-year vision but of course this can be annually updated. This task is to be completed by mid-August. The DoS will coordinate with PDs' before finalising.
