1. Minutes

- SMT has yet to approve the minutes of the 5 June meeting.

2. Report back

a. Sweden

- On 10 June, Luc and Laura attended the Swedish Lunch Summer Summit. Laura spoke about AI and geopolitics at the event.
- On 14 June, a delegation from the Kofi Annan International Peacekeeping Centre will visit SIPRI.

b. Relations with other organizations

- Sibylle was in Brussels on 10 June for various EUNPDC events, including the consortium's annual Steering Committee meeting. Sibylle was also at the EU Council today to present the consortium to member states.

c. Outreach

- SIPRI is conducting informal stakeholder surveys to better understand if the Yearbook meets the needs and interest of its diverse audience. The surveys will run until the end of July.
- Associate Senior Fellow Hans Kristensen will be in Stockholm from 16 – 20 June. While in Stockholm, he will take part in an SVT interview on SIPRI's nuclear forces data and other media engagements.
- Hans will also take part in the Stockholm Security Conference in October.

d. Operations

- This is a very intense time for GAD and PMO as several audits and project report deadlines are taking place simultaneously. There has also been significant progress on grant applications.

3. Delegation visits to SIPRI

- SMT agreed to have a standing item on its agenda on delegation visits for information sharing and decision making related to potential delegation visits.

4. Use of AI software

- SMT agreed that staff should monitor and follow guidance from the Swedish Research Council on the use of AI software. Each cluster and department should also discuss the topic at their next cluster or department meeting. - The advertisement for a new SIPRI Director was posted yesterday. Colleagues are encouraged to share the ad in their networks.

- HR and SMT are working on finding an appropriate date for the next staff survey.
