#### **2. Report back from clusters and departments**

##### **a) Sweden**

- Charlotta is now a mentor at Femme Defense, an organization for women active in defense and security issues.
- Karim and Luc met with colleagues from the European Institute for Peace, and they are interested in exploring several avenues for collaboration including dialogues, and an approach for the future of EU architecture.
- Jingdong was at a meeting with Swedish research institutions engaged in work on China, organized by the Swedish National China Centre and the Swedish Institute of International Affairs (UI).
- On Tuesday, 16 September, Karim and Steph met with a German historian who is interested in SIPRI's archive and had useful ideas how SIPRI could benefit from its history in the context of the jubilee year

##### **b) Relations with other organizations**

- Nan has been invited to speak at the SDG lounge event during UNGA high-level week. Joey shared the SIPRI Policy Brief: Rebalancing military spending towards achieving sustainable development for in-house review. SMT noted that this is a good example of a piece that can be turn into a short OP-ED (opinion piece).
- Sibylle, Mark, Katarina, Kolja and Michal are in Brussels this week to speak/moderate at the EU Non-proliferation and Disarmament Consortium's Consultative Meeting. The meeting focuses on engagement with members of the EU Council Working Party on Disarmament and Non-proliferation, and the EU Council Working Party on Conventional Arms Exports.

- Katongo is in Abyei for fieldwork together with colleagues from Norwegian Institute of International Affairs (NUPI). They are hosted by the United Nations Interim Security Force for Abyei.
